- safeguard the secrecy of personal credentials for the request of timestamps, keeping them in a safe place;

Remains in the applicant responsibility the procurement and utilization of an internet connection and of all the (hardware and software) required tools.

6. Certificate status checking obligations of relying parties.

Anybody relying on a timestamp, the Relying Party, must verify that the timestamp has been properly signed and that the relevant timestamp certificate has not been revoked.

Information on the status of TSU certificates is available consulting the list of revoked certificates (CRL) published by the TSA at the URL indicated on the certificate or through the OCSP service.

The request and/or verification of the Time Validation Service is available from 0:00 to 24:00, 7 days a week. TrustPro is committed to ensuring compliance with 95% of the above availability on an annual basis.

7. Limited warranty and disclaimer/limitation of liability

TrustPro may not be held liable for any damage arising from any incorrect usage of the timestamp. A predictable damage only may be refundable.

TrustPro has an appropriate insurance to cover risks of the QTSP activity and any damage deriving from the QTSP service.
